

TRIATHLON ZIMBABWE ELIGIBILITY CRITERIA FOR TZ ATHLETES TO THE 2021 SA CHAMPS and 2021 AFRICA CHAMPS

2021 SA CHAMPS: Durban

It is proposed to have a 'participation & performance' based criteria which qualifies athletes in the U13, U15, U17 and U19 age group categories as **ELIGIBLE** to attend the SA Champs in 2021. Eligibility will be determined by:

1. In the U13 category:

 a minimum of 4 races must be completed in the 2020/2021 season, 1 of which must be a qualifying time based race result in 2021.

2. In the U15, U17 and U19 categories:

- a minimum number of 10 points must be acquired from a graded-points for position-based system available in 7 designated selection events through the 2020/2021 season.
- an athlete's results from **all the designated selection events** in which they participate will count.
- in categories where numbers are small, a qualifying-time criteria will be applied in order for the athlete to attain their position points.
- 3. A 'Selectors' Discretionary Criteria' clearly laid out in this document which allows for possible inclusion of borderline eligibility cases *.

ELIGIBILITY CRITERIA AND POINTS SYSTEM FOR U15, U17 & U19 CATEGORIES

- 1) Eligibility is based on attaining a **MINIMUM** of **10** points available from 7 selection events.
- 2) The **Penhalonga & Troutbeck** events carry **specifically weighted position-based points**.
- 3) Local (Mt Pleasant Pool) events in 2021 are points weighted more than in 2020
- 4) Where there are only **1 or 2** competitors in the **U15**, **U17 or U19** category, to gain the respective position-based points in that event their finish time must be within the set qualifying time for their respective category as set out below:

QUALIFYING TIMES - required for small categories with only 1-2 competitors:

a. For MT PLEASANT POOL events - to gain the respective position-based points their finish time must be within the set qualifying time for their respective category:

U15 girls qualifying time: 44:00 U15 boys qualifying time: 41:00 U17 girls qualifying time: 1h22:00 U17 boys qualifying time: 1h15:00 U19 girls qualifying time: 1h20:00 U19 boys qualifying time: 1h10:00

b. For PENHALONGA and TROUTBECK events - to gain the respective positionbased points their finish time must be within the set qualifying time for their respective category:

U15 girls qualifying time: 53:00 U15 boys qualifying time: 49:00 U17 girls qualifying time: 1h29:00 U17 boys qualifying time: 1h22:00 U19 girls qualifying time: 1h27:00 U19 boys qualifying time: 1h17:00

* Selectors' Discretionary Criteria for borderline athletes:

- 1. The selectors will **only** review the eligibility of athletes who finish on **9 points** after the 7 selection events.
- 2. If the athlete's finish time in the super-sprint event is within **15 sec** of the qualifying time for any of the selection events in 2020 then he/she may receive an extra 1 point.
- 3. If the athlete's finish time in the selection sprint event is within **30 sec** of the qualifying time for any of the selection events in 2020 then he/she may receive an extra 1 point.

DISQUALIFYING CRITERIA FOR SELECTION

Disciplinary / Not in good standing with TZ, ATU or ITU

APPEALS PROCEDURE

- 1. All appeals must be submitted in writing to the Selection Committee within 24hrs of the athlete eligibility list announcement.
- 2. All appeals will be reviewed by the Selection Committee in line with the published Selectors' Discretionary Criteria.
- 3. Where a selector has a vested interest in the appeal, the relevant selector will recuse himself/herself and in this case or any other in which a selector is unavailable, then he/she will be replaced by a TZ board member appointed by the TZ Chair.
- 4. The decision of the Selection Committee is final and with NO onward recourse to the Executive Board.

ELIGIBILITY CRITERIA FOR NON-RESIDENT ATHLETES TO ENTER SA CHAMPS IN TZ TEAM

A non-resident Zimbabwean athlete can be considered for eligibility * based on either:

- 1. Placing 1st, 2nd or 3rd at their respective foreign 'Provincial' Champs in the 2020/2021 season (provided there are 4 or more athletes in the respective age category).
- 2. Submitting results of three (SA Champs age group equivalent distance) races he/she has completed in the period 1 October 2020 22 February 2021.
 - * These will be considered at the discretion of the Triathlon Zimbabwe Selection Committee

Note - to be considered for eligibility, the athlete is required to give Triathlon Zimbabwe a minimum of one month's notice prior to the SA Champs

DISQUALIFYING CRITERIA FOR SELECTION

Disciplinary / Not in good standing with TZ, ATU or ITU

APPEALS PROCEDURE

- 1 All appeals must be submitted in writing to the Selection Committee within 24hrs of the athlete eligibility list announcement.

ELIGIBILITY CRITERIA FOR THE 2021 AFRICA TRIATHLON CHAMPS – Egypt

Eligibility for the 2021 AFRICA CHAMPS SQUAD will be based on an athlete being of minimum 15 years of age and attaining **one** of the following:

- 1. A finish time within the qualifying time standard (QTS) set for their respective age-group at the 2021 Troutbeck event (as set out below.)
- 2. A finish time at the 2021 SA Champs within 10% of the relevant category winner's time.
- 3. A wild card entry to facilitate a full Zimbabwe team for the Mixed Team Relay event.

MIXED TEAM RELAY (Olympic Qualifier event):

The Mixed Team Relay team will compete as 2 male and 2 female athletes
selected from those who qualify for Africa Champs selection, with the option
of 1 male + 1 female reserve.
If 2 male + 2 female athletes do not qualify, the National Coach will
recommend 1 or 2 athletes to the TZ Selectors for a wild card entry based
on performance at Troutbeck / SA Champs.
The National Coach will decide the composition of the final relay team prior to
the Mixed Team Relay event in Egypt based on athlete performance.
